

Application for Notification to NSW Registry of Births Deaths & Marriages to Register an Intercountry Adoption

(for adoptions finalised in a country covered by the Hague Convention on Intercountry Adoption , or a prescribed overseas jurisdiction, where DCJ authorised the adoption)

November 2023

Adult adoptees (18 years and over) and the legal guardians of adoptees are able to apply for a NSW birth certificate for a child when his/her adoption was finalised in a country covered by the Hague Adoption Convention, or a prescribed overseas jurisdiction, and NSW Department of Communities and Justice (DCJ) authorised the adoption.

In order for a NSW birth certificate to be issued, the intercountry adoption must first be registered by NSW Registry of Births, Deaths & Marriages. To enable that registration to occur, DCJ must receive an application from you requesting DCJ to notify NSW Registry of Births, Deaths & Marriages of the adoption.

- A. Your application to Communities and Justice must be accompanied by the following certified copies (where applicable) of:
 - 1. The Certificate of Conformity of Intercountry Adoption (Compliance Certificate) issued by the Central Authority under Article 23 of the Hague Convention, or an adoption agreement from the prescribed overseas jurisdiction where the adoption was finalised;
 - 2. The Adoption Registration Certificate from the overseas country:
 - 3. Your child's Abandonment Certificate (if applicable);
 - 4. Court Civil Ruling Confirmation;
 - 5. Household Certificate which names the adoptive parents;
 - 6. The Letter of Confirmation from the Central Authority;
 - 7. The letter from the Central Authority to the Department of Home Affairs;
 - 8. The letter from the Department of Home Affairs advising of the Visa Grant Notice;
 - 9. Your child's current Australian passport and the overseas country passport;
 - 10. Your child's original birth certificate;
 - 11. Your child's Australian Citizenship certificate;
 - 12. Your passport as applicant/s;
 - 13. Your marriage certificate;
 - 14. Other child/ren's birth certificate/s from this relationship, if any.

<u>Please note:</u> Any document not in the English language must be attached with an English translation.

B. In the absence of above (No's 1-6) legal documents, please provide other relevant legal documents from the Central Authority or prescribed overseas jurisdiction where the adoption was finalised and Communities and Justice will undertake a file review.

C. Completed application form

The Intercountry Adoption Program of DCJ will review the application and your documentation. If all the material supplied is accurate, we will forward a letter of endorsement with your supporting material to NSW Registry of Births, Deaths & Marriages.

There is no fee for this application. However, once the adoption has been registered, the NSW Registry of Births, Deaths & Marriages will charge for the issue of a birth certificate.

<u>Please note:</u> Your application will not be processed until ALL required documentation is received and certified as detailed above. We thank you for your co-operation.
