Apply for a FACS scholarship to help with studies

FACS helps young people study by providing \$1,000 scholarships.

Jack from Wollongong received a FACS scholarship in 2017. He used it to buy a laptop so he could study at home while finishing Year 12.

It meant Jack didn't need to stay back after class and do all his homework at school.

The scholarship has given Jack a kick-start to achieve what he wants in future studies like learning video game programming.

Jack's thankful for the support and wants to see others apply.

You can apply for a scholarship if you are:

- a social housing tenant
- in Year 10, 11 or 12 at a NSW high school or TAFE college
- an Australian citizen or permanent resident
- a previous FACS scholarship recipient.

Applications open soon. There are 600 scholarships available for 2019.

Rental bonds encourage property care

On 1 November 2018, the NSW Government introduced FACS Housing rental bonds to encourage tenants to care for their property.

The vast majority of tenants look after their homes and will not have to pay a bond. You will only have to pay a bond if you cause damage of \$500 or more that is discovered and charged at a single point in time after 1 November 2018.

If the cost is less than \$500, you won't have to pay a bond. Damage that was previously reported will not count towards the \$500.

The bond will be four weeks' market rent or \$1,400, whichever is lower.

Former tenants who caused damage of \$500 or more that was discovered and charged at a single point in time in the six years before their new tenancy will also have to pay a bond.

Some vulnerable tenants are exempt from paying a bond, such as tenants who are over 80 years old.

Update: Antisocial behaviour policy

On 30 November 2018, our antisocial behaviour policy changed to encourage tenants to get support to sustain their tenancies.

When we receive a complaint

We investigate complaints to let each person tell their side of the story. If we confirm a tenant's first instance of minor and moderate antisocial behaviour, we help them find a support service.

We give the tenant a form to complete with the support service's help. If they return the form within 14 calendar days, they get a warning. If it's not returned or it's after 14 days, they get a first strike.

If the tenant already has a support service, they may ask for more help or focus on the antisocial behaviour.

If a service is full or not available in the area, the tenant will receive a warning and not a strike.

Three strikes policy

We introduced this policy to make social housing communities safer. If tenants receive three strikes within 12 months they may face eviction.
